RELEASE AND HOLD-HARMLESS AGREEMENT

The signature below indicates that the undersigned acknowledges the inherent risks involved in riding, driving, and being around horses, which risks include bodily injury from using, riding, driving, or being in close proximity to horses, among other risks, and further, that both horse and rider/driver can be injured in normal use or in competition and schooling.

WARNING

UNDER IOWA LAW, A DOMESTICATED ANIMAL PROFESSIONAL IS NOT LIABLE FOR DAMAGES SUFFERED BY, AN INJURY TO, OR THE DEATH OF A PARTICIPANT RESULTING FROM THE INHERENT RISKS OF DOMESTICATED ANIMAL ACTIVITIES, PURSUANT TO IOWA CODE CHAPTER 673. YOU ARE ASSUMING INHERENT RISKS OF PARTICIPATING IN THIS DOMESTICATED ANIMAL ACTIVITY.

A number of inherent risks are associated with a domesticated animal activity. A domesticated animal may behave in a manner that results in damages to property or an injury or death to a person. Risks associated with the activity may include injuries caused by bucking, biting, stumbling, rearing, trampling, scratching, pecking, falling, or butting.

The domesticated animal may react unpredictably to conditions, including, but not limited to, a sudden movement, loud noise, an unfamiliar environment, or the introduction of unfamiliar persons, animals, or objects.

The domesticated animal may also react in a dangerous manner when a condition or treatment is considered hazardous to the welfare of the animal; a collision occurs with an object or animal; or a participant fails to exercise reasonable care, take adequate precautions, or use adequate control when engaging in a domesticated animal activity, including failing to maintain reasonable control of the animal or failing to act in a manner consistent with the persons' abilities.

In consideration of those risks therefore, the undersigned agrees to hold harmless and indemnify Three G Farms Equine Center, Inc. and its representatives and employees and further releases them from any liability or responsibility for accident, damage, injury, or illness to the undersigned or any horse owned by the undersigned or to any family member or spectator accompanying the undersigned on the premises of Three G Farms Equine Center, Inc. The undersigned now has insurance in good standing to cover those risks. The undersigned agrees to provide and wear a riding/driving helmet while riding or driving horses on the premises of Three G Farms.
